## **Turf Field Use Policy**

## **General Provisions:**

- In accordance with the FCR's Player, Spectator and Coaches Codes of Conduct, <u>teams will be held</u> responsible for the behavior of their players. coaches. management and supporters. Performance bonds, fines, facilities ban can result.
- Verbal abuse towards FCR facility staff will not be tolerated. In accordance with the FCR's Player, Spectator and Coaches Codes of Conduct the FCR can and will assess fines and possible suspensions from the facility.
- Parents/guardians are responsible for the conduct, behavior and safety of their children. **Children must be supervised at all times. This includes the mezzanine level of the AffinityPlex.** The Facility staff is not responsible for the supervision of children.
- Field rental is in blocks of 55 minutes not one hour. You must immediately clear the field at the completion of your booked or blocked time. Extra time may result in extra cost for use.
- Metal cleated shoes are prohibited from use on the soccer turf. **Clean shoes only** are allowed on turf soccer fields (indoors and outdoors).
- **Only water is allowed on the turf.** No squirting of water is permitted. Sport drinks, alcohol, juices, coffee or similar liquids are prohibited in the playing area. <u>Upon completion of your game or practice, garbage</u> <u>and plastic water containers are to be disposed of in the receptacles provided.</u> Please respect the playing area and its use for others.
- Chewing gum or chewing tobacco products are not allowed on the turf field area. Persons using such products will be held responsible for any cleaning or replacement deemed necessary because of their use.
- Shell seeds (sunflower seeds, pumpkin seeds), pistachios and peanuts in the shell are not allowed.

## Indoor Turf (AffinityPlex)

• Caution should be exercised when walking or standing near the protective perimeter netting used in the AffinityPlex. The netting barrier provides a measure of protection but will not completely resist the impact of a kicked ball or player(s) crashing beyond the boundary of the field of play.

- All users of the AffinityPlex should be aware that the protective netting can be deflected significantly if impacted with great force. Spectators must ensure they maintain a safe distance from the perimeter netting to prevent contact with objects or persons that extend beyond the playing area.
- NO hanging or pulling on the perimeter netting or the goals. This will result in immediate expulsion from the playing surface.
- Blood spills, spit, vomit or any other body fluid(s) or matter that may present a bio-hazard must be reported to the FCR Soccer Facility Staff at the front desk immediately.
- **Spitting will not be tolerated** and can result in ejection from the facility and a suspension administered by the FCR Discipline Panel.
- Entering and exiting the playing area is only permitted at each field opening. Participants crawling through or under the protective netting may be ejected from the facility.
- A set of car keys is required to obtain a dressing room (key). Dressing rooms may be inspected for cleanliness and damages before the deposit is returned. Teams are responsible to leave dressing rooms in a tidy condition. Teams will be held accountable for any damages to dressing rooms.
- Participants or spectators found responsible for willfully damaging, defacing, destroying or theft of Futbol Club Regina, Regina Exhibition Association, AffinityPlex, Evraz Place or personal property of other users will be held responsible for all repair or replacement costs and will be subject to loss of facility privileges.
- Do not leave any valuables in the change rooms or unattended is the public area. The FCR is not responsible for lost or stolen articles.
- No Spectators are allowed on the turf playing surface. There is seating provided to watch activities from behind the protective netting.
- Use of compressed air powered horns, boating safety horns or any noisemaking devices that are deemed to be excessive during games are prohibited from use in the AffinityPlex.
- Vehicles parked in wheelchair access ramps may be towed immediately. Vehicles parked in designated handicapped parking areas without permits may be towed immediately. Any vehicles parked in a manner that creates unsafe conditions for our patrons may betowed.
- Pets and animals, other than service animals, are not allowed in the AffinityPlex. You will be asked to leave.
- Use of the Soccer Facility for activities other than originally contracted for will result in termination of the rental agreement and future access will be denied.
- <u>All users:</u> You are entering the only indoor facility of its kind in Regina. Please respect the rules of occupancy and help us keep this facility clean, safe and comfortable. Please use the litter receptacles provided and report any dangerous situations immediately.

Outdoor Turf - Leibel Field, Mosaic, U of R

- Spectators must remain outside the fenced area of the field or in the stands.
- Tents or other coverings with spikes are not allowed.
- Pets and animals, other than service animals, are not allowed inside the fenced area. You will be asked to leave.
